- 1. This contract is only concluded upon acceptance of the registration by the BVGA.
- 2. The contracting party confirms to the BVGA that it may use the logo and images of its golf course without restriction for the purposes of publication within the framework of the golf course classification.
- 3. In order to fulfill our duty of transparency, we refer to our data protection information sheet. This can be found on our homepage at: https://www.golfsterne.de/datenschutz.html
- 4. The contracting party bears the economic risk of not being able to operate its golf course in whole or in part for whatever reason. The contractual partner and the BVGA therefore agree that, in particular in cases in which the contractual partner's golf course cannot be operated in whole or in part due to government measures or force majeure, including in particular epidemics and pandemics, the annual fees shall also be paid by the contractual partner to the BVGA for such periods.
- 5. At the end of the contract, the star rating plate together with the certificate and classification flag must be returned to the BVGA and all references to the classification must be removed from the golf course (e.g. on the contractual partner's homepage).
- 6. A consumption period of 3 months after the end of the contract is granted for printing materials with the star logo.
- 7. The contractual partner is obliged to notify the BVGA immediately of any changes or defects that have occurred at the contractual partner's golf course that lead or may lead to a reduction in the rating (minimum criteria and survey form). Should changes or deficiencies in the contractual partner's golf course necessitate a change in the star category, the contractual partner shall have three months to withdraw the changes or rectify the deficiencies. The costs for the necessary reclassification (plus the costs for the inspector's travel) shall be borne by the contractual partner. If the defects are not rectified after two reminders, the BVGA reserves the right to terminate the classification with immediate effect.
- 8. In the event of changes to the contractual partner's golf course that lead or may lead to an increase in the rating (minimum criteria and survey form), the contractual partner may apply for a higher classification of the star category. In this case, the contractual partner shall bear the costs of reclassification (plus one-off travel costs for the auditor).
- 9. In order to be able to guarantee quality standards, the BVGA will carry out a regular mystery check every three years for all classified golf courses. With this quality assurance instrument, the required standards for golf courses can be checked in a timely manner and thus the current requirements of members and guests can be met in the best possible way. This step will help the employees of golf courses to achieve the highest possible customer satisfaction and ensure that classified golf courses continue to improve and offer top services.
