## Other agreements

1. This contract shall only come into effect upon acceptance of the registration by the BVGA.
2. The contracting partner confirms to the BVGA that it may use the logo of its golf course without restriction for the purposes of publication within the framework of the golf course classification.
3. In order to fulfil our duty of transparency, we refer to our data protection information sheet. You can find this on our homepage at <https://www.golfsterne.de/datenschutz.html>
4. The contracting partner shall bear the economic risk of not being able to operate its golf facility - for whatever reason - in whole or in part. The contracting partner and BVGA therefore agree that, in particular also in cases in which the contracting partner's golf facility cannot be operated in whole or in part due to government measures or force majeure, which in particular also includes epidemics, (including epidemics and pandemics), the annual fees shall also be paid by the contracting partner to BVGA for such periods.
5. After the end of the contract, the star rating plate together with the certificate and classification flag must be returned to the BVGA and all references to the classification must be removed from the golf course (e.g. also on the homepage of the contractual partner).
6. A consumption period of 3 months after the end of the contract is granted for print media with the star logo.
7. The contracting partner is obliged to notify BVGA immediately of any changes to or defects in the contracting partner's golf facility which lead or may lead to a reduction in the rating (minimum criteria and survey form). Should changes or deficiencies of the contracting party's golf facility require a change of the star category, the contracting party shall have three months to withdraw the changes or to remedy the deficiencies. The costs for the necessary reclassification (plus the costs for the journey of the inspector) shall be borne by the contractual partner. If the defects are not remedied after two reminders, the BVGA reserves the right to terminate the classification immediately.
8. In the event of changes to the contracting partner's golf facility which lead or may lead to an increase in the rating (minimum criteria and survey form), the contracting partner may apply for a higher classification of the star category. In this case, the contractual partner shall bear the costs for a reclassification (plus the costs for the journey of the inspector).
9. In order to be able to guarantee the assurance of quality standards, the Bundesverband Golfanlagen e.V. relies on quality checks. Experienced experts from the golf industry regularly check the fulfillment of requirements and guidelines of the golf course classification with the help of the current survey questionnaire and through regular test visits. This ensures that the quality of the golf facility always meets the current needs and requirements of the golf market. If we arrange for a quality check to be carried out, the contractual partner bears the travel costs of the inspector.
