### **Other agreements**

1. This contract shall only come into effect upon acceptance of the registration by the BVGA.
2. The contracting partner confirms to the BVGA that it may use the logo of its golf course without restriction for the purposes of publication within the framework of the golf course classification.

4. The contracting partner shall bear the economic risk of not being able to operate its golf facility - for whatever reason - in whole or in part. The contracting partner and BVGA therefore agree that, in particular also in cases in which the contracting partner's golf facility cannot be operated in whole or in part due to government measures or force majeure, which in particular also includes epidemics (including epidemics and pandemics), the annual fees shall also be paid by the contracting partner to BVGA for such periods.
5. After the end of the contract, the star rating plate must be returned to the BVGA and all references to the classification must be removed from the golf course (e.g. also on the homepage of the contract partner).
6. A consumption period of 3 months after the end of the contract is granted for print media with the star logo.
7. The contracting partner is obliged to notify BVGA immediately of any changes or defects that have occurred in the contracting partner's golf course, which lead or could lead to a reduction in the rating in accordance with the Short Course Seal survey form. If changes or defects of the golf course of the contracting party require a change of the category, the contracting party shall have three months to withdraw the changes or to remedy the defects. If this is not done, the contractual partner shall bear the costs for the necessary reclassification. If the deficiencies are not remedied after two reminders, the BVGA reserves the right to terminate the classification immediately.
8. In the event of changes to the contracting party's golf course, which lead or may lead to an increase in the rating in accordance with the survey form for the short course seal, the contracting party may apply for a higher classification. In this case, the contractual partner shall bear the costs for reclassification.
